The district will provide opportunities for ongoing support and coaching of the campus leaders throughout the execution of the grant and development of the Targeted Improvement Plan. The district will work in collaboration with Horizon Montessori-Pearland to craft and implement their TIP by providing guidance, training, and support from consultants to ensure that the Targeted Improvement Plan produced is meaningful, relevant, and addresses the needs of the campus.

The district will monitor the campus receiving the ESF-Focused grant in a variety of ways. To monitor their Targeted Improvement Plan submission and implementation, the district will set deadlines and meetings for collaboration and feedback for submission and ongoing progress monitoring of all aspects of the TIP. To monitor additional actions to meet the barriers and challenges of the first year of the grant cycle, the district will meet with the campus principal after being awarded, and create a plan of action to monitor the implementation and execution of the grant. In addition the district will work in collaboration with the campus principal to develop solutions to barriers as they arise.

The campus principal will have the flexibility to build capacity in their teachers and take actions on the initiatives set forth in the grant.

The proposed budget meets the needs and goals of the program at Horizon Montessori-Pearland. The budget focuses on our identified areas of improvement centered around instruction and development of our teachers and instructional leaders. Throughout the 2 year cycle, our partnership with Instruction Partners will build capacity in our teachers' practices that will yield students who are performing the cognitive lift necessary to think critically and master concepts.

The entirety of the budget is leveraged for targeted support in implementing systemic change in the instructional practices at Horizon Montessori-Pearland. Through focused implementation of strategies and best practices through professional development and coaching, our goals of all of our students learning at high levels, are engaged in their learning, and performing at or above grade level can be attained.

If adjustments are needed, we will work with all parties involved to determine the best course of action to best support our campus. If after beginning our work together, we determine another instructional need takes precedence or is identified as a need by our campus teachers, instructional leaders, and students we can pivot to ensure our teachers are supported in producing the desired outcomes for student learning. Together we would collaborate and agree that the adjustments are reflective of the needs of the actions in the diagnostic and TIP and adheres to the guidelines set forth by the grant.
