## Reporting Student Data File Format

## Overview

All STAAR data for end-of-course (EOC) assessments will be reported in a unique data file for each EOC administration. There will be one record on the data file for each subject for which a student is assessed. Following is a list of the most significant changes being implemented in the Spring and Summer 2023 administrations.

1. **ADMINISTRATION DATE** – Updated to reflect current test administration periods of Spring and Summer 2023. (Position 1)
2. **FALL 2022 TSDS PEIMS HOMELESS-STATUS-CODE** – New field from the PEIMS database. (Position 110)
3. **SECTION-504-INDICATOR-CODE** – New field added in TIDE. (Position 112)
4. **DISCREPANCY INDICATOR** – Type 1 Discrepancy has been removed as there are no scanned paper tests. (Position 143)
5. **FALL 2022 TSDS PEIMS STUDENT-LANGUAGE-CODE** – New field from PEIMS database. (Position 153)
6. **AGENCY USE** – \* is no longer an acceptable value as there are no scanned paper tests. (Positions 215-219)
7. **DESIGNATED SUPPORTS** – This field has been replaced with a blank. (Position 252)
8. **NON-EMBEDDED DESIGNATED SUPPORTS** – This field replaces the “Oral Administration” field and has new acceptable values. *Oral Administration is no longer collected at the state level.* (Position 255)
9. **SCORE CODE DEFAULT** – 1 no longer indicates multiple gridded values since there are no scanned paper tests. (Position 296)
10. **REPORTING CATEGORY 6 RAW SCORE** – Removed to reflect the updated blueprint. This field has been replaced with a blank. (Position 361)
11. **PERFORMANCE LEVEL INDICATOR** – New field added to indicate student’s growth from the previous year in Algebra 1, English I and English II. (Position 363)
12. **EXTENDED CONSTRUCTED RESPONSE SCORE** – Acceptable values updated to 0-10 to reflect updated test blueprint. (Position 372)
13. **STUDENT’S PASSING STANDARD FOR APPROACHES GRADE LEVEL** – “3” has been added as an acceptable value for students taking an EOC in Spring 2023 and beyond. (Position 387)
14. **APPROACHES GRADE LEVEL AT THE 2015-2022 STANDARD** – New field added. (Position 394)
15. **STAAR PROGRESS MEASURE** – STAAR Progress Measure will not be reported in 2023. Related fields have been replaced with blanks. (Positions 395-417)
16. **ITEM STUDENT RESPONSES** – \* no longer indicates multiple gridded values since there are no scanned paper tests. New acceptable values for non-multiple-choice items. (Position 499)
17. **POINTS POSSIBLE** – Field added to indicate the number of points possible for each item from 0-2. (Positions 833-896)
18. **CUMULATIVE HISTORY: ENGLISH I WRITTEN COMPOSITION** – Moved from Position 1238 to Position 1240-1241.
19. **CUMULATIVE HISTORY: ENGLISH II WRITTEN COMPOSITION** – Moved from Position 1338 to Position 1340-1341.
